

Terms and Conditions of User License MIDA Model v1.0

The Licensee and any person who copies, installs and/or otherwise uses the MIDA Model v1.0 licensed (the "User") agrees to be bound by the following terms and conditions (the "Agreement"):

1. Software

The MIDA Model is distributed as a voxelized model in MAT, RAW, NII, and TXT file formats and as a CAD model in STL file format (the "Model Data") and the MIDA Model Installer (the "Installer").

2. License

- 2.1 The Foundation for Research on Information Technologies in Society, Zeughausstrasse 43, 8004 Zurich, Switzerland, (referred to below as "IT'IS Foundation") grants the Licensee a non-exclusive, non-transferable, free license to use the Model Data and the Installer.
- 2.2 The licence will be granted for an unlimited period of time.
- 2.3 The following shall apply to the license:
 - 2.3.1 Any modified version of, or derivative work based on, the Model Data shall bear the notice that it is a modified version of, or derived from the MIDA Model.
 - 2.3.2 The Model Data or works derived from the Model Data must not be distributed or redistributed in the original form or in any modified or updated form.
 - 2.3.3 Any images based on the Model Data may be published only if the face is disguised so as to render the individual unrecognizable in any and all communications of any kind, including but not limited to reports, papers, and oral or poster presentations, in which images are published.
 - 2.3.4 When the Model Data is loaded, it must neither be read from the computer memory or graphics card memory nor be intercepted on the data bus.
 - 2.3.5 The Installer and the Model Data shall not be used for military purposes, in particular for the development and optimization of potentially lethal weapons. Exceptions might be possible for protection of civilians and soldiers, e.g., from exposures to radar and/or communication equipment.
 - 2.3.6 The Installer is supplied in object code. The User is not permitted to decompile, decrypt, disassemble, retrieve by reverse engineering of any kind, otherwise make available the source code of, or modify the Installer, or to create derivative works.
 - 2.3.7 It is not permitted to include the Installer into any other software or to start the Installer using other software.
 - 2.3.8 In the event that data or results that have been obtained inter alia through use of the Model Data are published in communications of any kind, including but not limited to reports, papers, and oral or poster presentations, reference shall be made in the publication to FDA, Center for Devices and Radiological Health, and IT'IS Foundation as the creators of the Model Data and to the following paper: MIDA: A Multimodal Imaging-based Detailed model of the Anatomy of the human head and Neck.  - 2.3.9 This Agreement does not convey any title to intellectual property rights in the Model Data and/or Installer, nor shall the Licensee or any User attempt to obtain any such title to intellectual property rights in the Model Data and/or Installer.
 - 2.3.10 In the event that IT'IS Foundation is informed that the person, on whose personal data the Model Data is based has withdrawn the consent for any further use of the Model Data, IT'IS Foundation will inform the Licensee that any further use whatsoever of the Model Data is strictly forbidden.

3. Warranty

- 3.1 The Licensee and/or User are aware that no software runs completely error-free. Furthermore, the Licensee and/or User are responsible for the selection and the use of the Installer and Model Data as well as of the hardware and other software programmes to be used together with the Installer and Model Data.
- 3.2 IT'IS Foundation makes no warranties whatsoever relating to the Model Data and its use and operation alone or in conjunction with any other software or for any purpose whatsoever. IT'IS Foundation disclaims in particular, but not

exclusively, any warranties of accuracy, completeness, usefulness of the Installer and Model Data and any related documentation or for fitness of the Installer and Model Data for any particular purpose. IT'IS Foundation makes no representation that the use of the Installer and Model Data does not infringe any third party rights.

4. Liability

- 4.1 Any liability of IT'IS Foundation for damages caused by the use of the Installer and/or the Model Data, in particular, but not limited to, indirect, consequential, and incidental damages, interruption of operations, loss of use, loss of profit, loss of data and information, loss of good will, shall be excluded to the maximum extent permissible by law.
- 4.2 The Licensee and/or User shall be fully liable to IT'IS Foundation for, and agrees to hold IT'IS Foundation harmless of any damage caused by any breach of this Agreement, in particular by any breach of clause 2.3.

5. Termination

This Agreement terminates with immediate effect if the Licensee and/or any User is in breach of the terms of this Agreement, in particular clause 2 above. Upon termination, Licensee shall return the Installer and Model Data to IT'IS Foundation and confirm in writing that all copies of the Installer and Model Data on any of its installations have been deleted.

6. Miscellaneous

- 6.1 Entire Agreement: This Agreement embodies the entire understanding between IT'IS Foundation and the Licensee and/or User with respect to the subject matter of this Agreement, and there are no representations, warranties, covenants, agreements or collateral understandings, oral or otherwise, other than expressly set forth herein.
- 6.2 Without prejudice to any rights of IT'IS Foundation against any User, the Licensee shall be responsible and ensure that any User who in any manner uses the Model Data and the Installer that have been licensed to the Licensee, complies with the Agreement.
- 6.3 Assignment: The Licensee and/or User shall not assign or transfer this Agreement as a whole or in part to any third party without the prior express and written consent of IT'IS Foundation.
- 6.4 Waivers: No waiver by IT'IS Foundation of any breach of the Agreement by the Licensee or User shall be considered as a waiver of any subsequent breach of the same or any other provision.

7. Governing Law and Jurisdiction

- 7.1 This Agreement as well as any dispute arising out of or in connection with this Agreement shall be subject to and interpreted in accordance with the laws of Switzerland.
- 7.2 All disputes arising out of or in connection with this Agreement shall, to the exclusion of any other courts, be settled by the Commercial Court of the Canton of Zurich, Switzerland. Should the amount in dispute not reach the amount required by law for jurisdiction of the Commercial Court, the District Court of Zurich, Switzerland, shall have exclusive jurisdiction instead. Notwithstanding and without prejudice to the foregoing, IT'IS Foundation shall also be entitled to bring action against the Licensee or User at any other court having competent jurisdiction.
